I appreciate you contacting my office with your questions regarding House Bill 4459, a bill I have proudly sponsored and now unfortunately languishes in the House Committee on Local Government and Urban Policy. I would encourage you to check on its progress periodically at www.legislature.mi.gov.

When I introduced this legislation at the beginning of the 2005/2006 legislative session I had high hopes that we would finally see action on this issue. I have urged my colleagues on the committee to allow me to have a hearing, but unfortunately it is not a priority of the current majority party.
