Frank Accavitti introduced, Bill #4429 March 1, 2007 and once again he is championing the cause for those who live Manufactured Housing Communities. This Bill is called the "manufactured home owners' residency act." This Bill will establish and protect the rights of manufactured home park residents entitled and give them rights they have been denied. The Officers of MOCOM (Manufactured Homeowners Coalition of Michigan, Inc.) and Representative Frank Accavitti had authored the Bill previously but it was not passed into LAW.

Mr. Accavitti cares about his constituents and citizens that live in Michigan and has stated he would work to get the other Representatives to be in agreement to get the BILL passed.

We will have to wait and see if our Legislators, once again, will stall and not push to have the Bill get out of COMMITTEE and passed to the Senate.

We desperately need to have BILL #4429 passed for it will give homeowners, in these communities, rights they have been denied for too long. This BILL will help to restore our dignity by giving us a voice concerning our living conditions and would stop the harassment, discrimination, intimidation, threats of eviction etc.

We question why are homeowners renting in Manufactured Housing Communities being discriminated against by our LEGISLATURE, Representatives and Senators both at the State and Federal level. We are homeowners fighting for rights we have been denied because we rent the land in these communities. If there were affordable housing in our STATE, every state, in the United States, there would be no need for these communities. There are more and more homeless people on the streets in shelters because our government does not push for and provide affordable housing for the less fortunate, jobless, elderly, low income and retired people in our country.
